I am the registered owner of the vehicle and agree to furnish title to the dealer immediately upon notification of sale. There are no interests, liens or claims against the vehicle except those listed below:

I understand that, pending sale, title shall remain in owner's name, who shall carry their own fire, theft, liability and other insurance required on said vehicle. I hold the consignee, his agents, harmless from any loss or damage to the vehicle by fire, theft, accident, vandalism or any other causes whatsoever.
